

COMMISSION MEETING MINUTES  
CITY OF LAWRENCEBURG  
JULY 7, 2005

The Mayor and Board of Commissioners met in regular session. The following members were present: Commissioner Butch Morrow, Commissioner Keith Durham, Commissioner Tim Dickey, Mayor Allen Chapman and Commissioner Buford Goolsby.

With a quorum present, the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Mayor Chapman made a motion to approve the minutes of the June 16 meeting and the Special Called Meeting of June 28th, with a second by Commissioner Dickey. Motion passed unanimously.

Mayor Chapman welcomed newly elected Commissioner Butch Morrow, and reappointed Bert Spearman and Lonnie Bailey to the Planning Commission with their terms to expire June 30, 2008.

In Old Business Chief Shay reported that a study is underway at the Highway 43-Dunn Road intersection and the State of Tennessee Department of Transportation indicated that there would also be a physical study done there also. They will report back to us when the study is complete.

In New Business the election of the new Vice Mayor was addressed. Commissioner Dickey nominated Keith Durham, with a second by Commissioner Goolsby. Nominations ceased and Commissioner Durham was unanimously elected Vice Mayor for the next two years.

The Public Hearing was opened on Ordinance # 995, with no one wishing to address the Commission concerning Ordinance # 995, the Public Hearing closed.

Attorney Betz presented 1 ordinance and 5 resolutions for consideration by the board.
