

COMMISSION MEETING MINUTES
CITY OF LAWRENCEBURG
JULY 20, 2006

The Board of Mayor and Commissioners met in regular session. The following members were present: Commissioner Keith Durham, Commissioner Butch Morrow, and Commissioner Tim Dickey. Mayor Allen Chapman and Commissioner Buford Goolsby were absent.

With a quorum present, Vice Mayor Durham called the meeting to order. The meeting opened with Prayer by Steve Seaton, Youth Pastor at Immanuel Baptist Church and the Pledge of Allegiance. The prayer was especially for Commissioner Goolsby concerning his illness.

A motion to approve the minutes of the July 6th meeting was made by Commissioner Morrow, with a second by Commissioner Dickey. Motion passed unanimously.

Commissioner Durham welcomed Renee Chandler of the Lawrenceburg Utility Systems and she introduced Mr. Dave Mullholand the new Chief Operating Officer and Vic Pusser, the Engineering Coordinator.

Vice Mayor Durham asked everyone to remember Commissioner Goolsby and his family during this difficult time. He also reminded everyone of the upcoming J. D. Vaughan Gospel Music Festival next weekend and Commissioner Dickey reminded everyone of the concert on the square this weekend.

Police Chief, Terry Shay, gave a report on the Police Department and the stats for last year and the second quarter of this year. He also reported that we should be receiving information on the speed limit issue south of town from MTAS soon.

Commissioner Morrow informed the Commission that he attended a meeting this week concerning the Multiplex Center; they will be holding a public meeting on August 15th. The estimated cost of the Center, at this time is approximately Eight Million Dollars. He also wants the Commission to begin discussion on the renovation of City Hall and the issue of roadblocks.

Commissioner Morrow asked for the City of Lawrenceburg to join with the State of Tennessee on the "Sales Tax Holiday" for school supplies and clothing. The city will check into the process.

Attorney Betz presented three Resolutions for consideration.

Motion to approve was made by Commissioner Dickey, with a second by Commissioner Morrow. Motion passed unanimously.

2006-20-7C A RESOLUTION FOR THE CITY OF LAWRENCEBURG, TENNESSEE, TO ACCEPT THE BID OF PARRIS CONSTRUCTION, INC. IN THE AMOUNT OF FOUR HUNDRED THIRTY NINE THOUSAND, SEVEN HUNDRED EIGHTY DOLLARS (\$439,780.00)

FOR THE REPLACEMENT OF SEWER LINES LOCATED IN BASIN
TEN (10), FUNDED BY A COMMUNITY DEVELOPMENT BLOCK
GRANT WITH LAWRENCEBURG UTILITY SYSTEMS PROVIDING
MATCHING FUNDS.
