

COMMISSION MEETING MINUTES  
CITY OF LAWRENCEBURG  
AUGUST 17, 2006

The Board of Mayor and Commissioners met in regular session. The following members were present: Commissioner Keith Durham, Commissioner Butch Morrow, Commissioner Tim Dickey and Commissioner Buford Goolsby. Mayor Allen Chapman was absent.

With a quorum present, Vice Mayor Durham called the meeting to order. The meeting opened with Prayer and the Pledge of Allegiance.

A motion to approve the minutes of the July 20<sup>th</sup> meeting was made by Commissioner Morrow, with a second by Commissioner Goolsby. Motion passed unanimously.

Vice Mayor Durham announced the Antique Tractor Show this week-end and the Quilt Display at the Crockett Arts Center.

He also announced that city offices will be closed on September 4<sup>th</sup> for Labor Day and garbage pick-up for that Monday will be picked-up the following Thursday, September 7<sup>th</sup>. Please have carts out early.

Norman Simbeck with the Lawrence County Produce Growers Association spoke to the Commission asking their support and partnership to apply for a grant in October, and to assist them in finding a suitable location for them to sell their produce.

Vice Mayor Durham explained that the Planning Commission is looking into changing the ordinance that is creating a problem for the Produce Growers in finding a suitable location, and they will introduce changes to the City Commission for approval.

Daphene Cope with the Lawrence County Chamber of Commerce asked the Commission to partner with them in making a grant application through the State of Tennessee Roadscapes Program. (Resolution follows.)

Attorney Betz presented one Ordinance and eight Resolutions for consideration.

1009 TO AMEND ORDINANCE 1007; AND ORDINANCE FOR THE CITY OF LAWRENCEBURG, TENNESSEE ADOPTING A BUDGET FOR THE FISCAL YEAR JULY 1, 2006, THROUGH JUNE 30 2007 TO REFLECT REVENUES IN THE SANITATION FUND APPROPRIATED BY THE GENERAL FUND IN THE AMOUNT OF ONE HUNDRED EIGHTY FOUR THOUSAND SIX HUNDRED SEVENTY FOUR DOLLARS (\$184,674.00) PER REQUEST BY THE STATE OF TENNESSEE COMPTROLLER'S OFFICE. Motion to approve was made by Commissioner Dickey, with a second by Commissioner Goolsby. Motion passed unanimously.

Vice Mayor Durham asked for any other comments from Commissioners before adjournment. Commissioner Morrow talked about Multiplex concept, and suggested further discussion with the Commission on the project. He also mentioned the hand-out concerning the sidewalk restoration project in front of Crockett Theater.

Commissioner Dickey thanked the Multiplex Committee for all their hard work and suggested the need for much more information.

City Administrator Sellers informed the Commission and the press that on Tuesday, August 22<sup>nd</sup> Helton Drive will be closed from 7:30 a.m. until dark for the installation of the new rail-road crossing.

With no further business to come before the board, a motion to adjourn was made by Commissioner Dickey, with a second by Commissioner Morrow. Motion passed unanimously.
