## COUNCIL MEETING MINUTES CITY OF LAWRENCEBURG MAY 14, 2009

The Board of Mayor and Council met in regular session. The following members were present: Council Member Ronald Fox, Council Member Jerry Moore, Council Member Robin Williams, and Council Member Butch Morrow. Mayor Durham was absent.

With a quorum present Vice Mayor Morrow called the meeting to order. The meeting opened with Prayer and the Pledge of Allegiance.

A motion to approve the minutes of the April 23, 2009 meeting was made by Council Member Williams, with a second by Council Member Fox. Motion passed unanimously.

Vice Mayor Morrow congratulated Ronald Fox on being elected to Office and Congratulated Jamie Sevier on his election. Mr. Eddie Cothren was also present and Vice Mayor congratulated him on his run for election. Congratulations were also sent out the Kelly Family for 50 years of Gospel Music singing.

Vice Mayor Morrow mentioned the Beautification Board's Memorial Cross Project and the Memorial Day Program at the City Administration Building on May 25<sup>th</sup> at 6 PM. He also encouraged citizens to participate in the Civil War Exhibit.

Council Member Fox thanked Butch Morrow for his 16 years of Public Service.

Vice Mayor Morrow reminded everyone that City Offices will be closed on Monday, May 25<sup>th</sup> and garbage carts will be picked up on Thursday, May 28<sup>th</sup>.

City Administrator William McLain introduced Jayne Shaw and explained that there was some miscommunication in the last work session concerning her funding.
