

COUNCIL MEETING MINUTES
CITY OF LAWRENCEBURG
OCTOBER 22, 2009

The Board of Mayor and Council met in regular session. The following members were present: Council Member Ronald Fox, Council Member Robin Williams, Council Member Jamie Sevier, Mayor Durham and Council Member Moore.

With a quorum present Mayor Durham called the meeting to order. The meeting opened with Prayer and the Pledge of Allegiance.

A motion to approve the minutes of the October 8, 2009 meeting was made by Council Member Williams, with a second by Council Member Sevier. Motion passed unanimously.

Mayor Durham announced the closing of city offices on November 11 in observance of Veteran's Day, and asked Beth Campbell to give details on Halloween in Rotary Park.

Mayor Durham introduced Keri Beth Wilkins the Key Club K-T District Governor and Abigail McKamey the Key Club International President and presented them with Outstanding Achievement Awards.

Mayor Durham then presented a Proclamation on behalf of all caregivers for National Care Giver Month (November). Several different groups of care givers were present for the presentation.

Mayor Durham then turned over the meeting to City Administrator William McLain.

Mr. McLain informed the council that Nashville Symphony ticket sales were not going well. He also presented the Council with the quarterly financial report and information on a proposed change in the web site.

Mr. McLain asked Fire Chief Don to address the Council concerning False Alarms. Don Kelly and Police Judy Moore both spoke on the subject and asked the Council to consider an ordinance with fine for excessive calls.

The Council was very receptive to the idea.

Attorney Alan Betz had one resolution for consideration.

Department Managers Jerry Smith, Joe Baxter and Gary Hyde briefed the Council on recent activities in their departments and activities expected to take place shortly.

Council Member Sevier asked about the possibility of Solicitation Permits for anyone soliciting for funds in Lawrenceburg.

With no further business to come before the Board a motion was made by Council Member Fox to adjourn, with a second by Council Member Williams. Motion passed unanimously.
