

COUNCIL MEETING MINUTES
CITY OF LAWRENCEBURG

July 12, 2012

The Board of Mayor and Council met in regular session. The following members were present: Council Member Robin Williams, Council Member Chad Moore, Council Member Jamie Sevier, Council Member Ronald Fox and Mayor Keith Durham.

With a quorum present the Mayor called the meeting to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the June 28, 2012 Council Meeting was made by Council Member Moore with a second by Council Member Sevier. Motion passed unanimously.

Mayor Durham informed the Council of the reappointment of Pam Harris and Raymond Marston to the Regional Planning Commission with their terms to expire June 30, 2015.

Mayor Durham presented Bubba Bryant a retirement award for over 28 years of service to the City of Lawrenceburg Police Department as Captain of the Reserve Officers and School Crossing Guard.

City Administrator William McLain informed the Council on the condition of the basement at the Old Armory and suggested they consider what the City should do as far as closing it or repairing it. It has no electricity and is very dirty. Some citizens still use it during storms. It was determined that citizens should be locked out of the basement until it has been made safe for use.

He also informed the Council that Mr. James Allen Whitehead has requested financial information concerning the Crockett Theater. He is concerned about the usage of the theater without city personnel in attendance.

City Attorney Betz presented 3 ordinances and 4 resolutions for consideration by the City Council.

ORDINANCE NO. 1098

AN ORDINANCE OF THE BOARD OF MAYOR AND COUNCIL OF THE CITY OF LAWRENCEBURG TO REGULATE AND PROHIBIT THE PARKING OF MOTOR VEHICLES AND OTHER VEHICLES ON TORGES STREET, BETWEEN BUFFALO ROAD AND SMITH AVENUE. Second and final reading

Motion to approve on final reading was made by Council Member Williams, with a second by Council Member Fox. Motion passed unanimously.

ORDINANCE NO. 1099

AN ORDINANCE OF THE BOARD OF MAYOR AND COUNCIL OF THE CITY OF LAWRENCEBURG TO REGULATE AND PROHIBIT THE PARKING OF MOTOR VEHICLES AND OTHER VEHICLES ON CARROLL AVENUE, BETWEEN WEST TAYLOR STREET AND WEST SCOTT STREET. Second and final reading.

Motion to approve on first reading was made by Council Member Moore with a second by Council Member Fox. Motion passed unanimously.

ORDINANCE NO. 1100

AN ORDINANCE TO ESTABLISH RULES AND REGULATIONS FOR EXCAVATION IN ANY STREET, ALLEY, ROADS, SIDEWALKS, OR PUBLIC PLACES WITHIN THE CITY OF LAWRENCEBURG AND TO ESTABLISH GUIDELINES FOR CUTS AND EXCAVATIONS PERFORMED BY THE LAWRENCEBURG UTILITY SYSTEMS. Second and final reading.

Motion to approve was made by Council Member Fox, with a second by Council Member Sevier. Motion to amend the Ordinance was made by Council Member Moore with a second by Council Member Sevier. City Attorney presented amendments to the ordinance to change the heading and body to include roads and sidewalks; and to add All Cuts shall be done by saw cut

where feasible. Upon vote to approve Ordinance Number 1100 as amended , the vote was unanimous.

Motion to approve was made by Council Member Moore, with a second by Council Member Williams. Motion passed unanimously.

2012-12-7C A RESOLUTION FOR BOARD OF MAYOR AND COUNCIL OF THE CITY OF LAWRENCEBURG, TENNESSEE TO RE-APPOINT ORA GREEN AND GALA GLASS TO THE BOARD OF ZONING APPEALS.

Motion to approve was made by Council Member Williams, with a second by council Member Fox. Motion passed unanimously.

2012-12-7D A RESOLUTION OF THE BOARD OF MAYOR AND COUNCIL OF THE CITY OF LAWRENCEBURG, TENNESSEE TO PARTICIPATE IN THE TML RISK MANAGEMENT POOL "SAFETY PARTNERS" LOSS CONTROL MATCHING GRANT PROGRAM.

Motion to approve was made by Council Member Moore, with a second by Council Member Fox. Motion passed unanimously.

Council Member Sevier informed the Council on the progress made for the Mission Clean Up in Lawrenceburg.
