

COUNCIL MEETING MINUTES
CITY OF LAWRENCEBURG

July 26, 2012

The Board of Mayor and Council met in regular session. The following members were present: Council Member Robin Williams, Council Member Jamie Sevier, Council Member Ronald Fox and Mayor Keith Durham. Council Member Moore was absent

With a quorum present the Mayor called the meeting to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the July 12, 2012 Council Meeting was made by Council Member Williams with a second by Council Member Fox. Motion passed unanimously.

Mayor Durham reminded everyone of the James D. Vaughan Music Festival this week-end.

Fire Chief Don Kelley updated the Council on the stats for the Fire Department this past year. They had a total of 2024 calls with the average response time being 4 minutes. 58% of all calls were medical, with the majority of them being handled by Fire Station 1. Sixteen personnel work the scene of a fire. Some calls are being called in directly other than 911. Chief Kelly reiterated all emergency calls should come through 911

City Attorney Betz presented 2 ordinances and 1 resolution for consideration by the City Council.

Motion to approve on first reading was made by Council Member Fox, with a second by Council Member Williams. Motion passed unanimously.
