

COUNCIL MEETING MINUTES  
CITY OF LAWRENCEBURG

July 28, 2011

The Board of Mayor and Council met in regular session. The following members were present: Council Member Ronald Fox, Council Member Jamie Sevier, Mayor Durham, Council Member and Council Member Robin Williams. Council Member Chad Moore was absent.

With a quorum present Mayor Durham called the meeting to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the July 14, 2011 Council Meeting was made by Council Member Sevier with a second by Council Member Williams. Motion passed unanimously.

Cindy Murdock-Elliot, Director of the Tennessee Rehab Center in Columbia spoke to the Council concerning funding for the organization.

Mayor Durham announced that the 14 year old Babe Ruth Baseball Team in competing in the South East Regional Tournament in Greenville, North Carolina.

Ordinance No. 1081 states in Section 10: There is hereby levied a property tax of \$1.4234 per \$100 of assessed value on all real and personal property.

Motion to approve Ordinance No. 1081 on first reading was made by Council Member Williams, with a second by Council Member Sevier. Motion passed unanimously.

**Ordinance No. 1082 – AN ORDINANCE TO CREATE A PUBLIC WORKS DEPARTMENT – First Reading**

Motion to approve Ordinance No. 1082 on first reading was made by Council Member Fox, with a second by Council Member Williams.

Motion made by Mayor Durham to amend Ordinance No. 1082 by placing a period at the end of the word Department in the last sentence of Section II: DUTIES and deleting the words (sometime in the near future.)

Motion received a second by Council Member Sevier. Motion passed unanimously.

Vote to approve Ordinance No. 1082 on first reading as amended passed unanimously.
