COUNCIL MEETING MINUTES CITY OF LAWRENCEBURG

August 25, 2011

The Board of Mayor and Council met in regular session. The following members were present: Council Member Ronald Fox, Council Member Jamie Sevier, Mayor Durham, Council Member Robin Williams, and Council Member Chad Moore.

With a quorum present Mayor Durham called the meeting to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the August 11, 2011 Council Meeting was made by Council Member Moore with a second by Council Member Williams. Motion passed unanimously.

David Sutton was presented a retirement plaque for 30 years of service to the City of Lawrenceburg through the Street Department.

Mayor Durham announced the closing of city offices on September 5 in observance of Labor Day and garbage pick-up will be on the morning of September 8. September 14th at 8:00 a.m. the city will hold a Mayor's Prayer Breakfast. The refreshments for the breakfast will be furnished by members of the community.

City Administrator informed the Council that the Commissioner of Transportation will be on the square on September 15 around 11:30 a.m. He is touring TDOT projects and will discuss the Downtown Enhancement Grant. Also on September 8th after Council Meeting David Weathers Charities will present a check to the city to help defray the cost of repairs to the tennis courts at 10:00 a.m. at the LCHS Tennis Courts.

Mr. McLain also announced we have four new employees. Three in the Police Department; Chief Moore announced Terry Beecham, Kevin Williams, and Michael Reeves have begun work in her department. All these officers were certified and have begun work on the streets. Officer Reeves is a Certified Crash Reconstructionist; something we have never had.

Chief Don Kelley announced that Eric Smith has been hired in the Fire Department. He was a reserve firefighter and has all his required training.

City Attorney Betz presented 1 ordinance and 3 resolutions for consideration by the City Council.
