

COUNCIL MEETING MINUTES
CITY OF LAWRENCEBURG

September 13, 2012

The Board of Mayor and Council met in regular session. The following members were present: Council Member Robin Williams, Council Member Ronald Fox, Mayor Keith Durham and Council Member Moore. Council Member Sevier was absent.

With a quorum present the Mayor called the meeting to order. The meeting opened with Prayer and the Pledge of Allegiance.

Department Manager, Beth Campbell and her family were remembered in prayer for the loss of her Father Robert Binkley. Police Officer, Shane Casteel and his family were also remembered due to his illness.

Motion to approve the minutes of the August 23, 2012 Council Meeting was made by Council Member Williams with a second by Council Member Fox. Motion passed unanimously.

Mayor Durham presented Police Chief, Judy Moore with a certificate of Outstanding Achievement for being selected to serve on the Tennessee Association of Chiefs of Police Board of Directors for 2012-2013 for Lawrence, Bedford, Giles, Lewis, Lincoln, Maury and Moore Counties, and receiving certification on the first annual Chief Executive Leadership Development Program.

Department Manager Gary Hyde at the request of Council Member Sevier gave a report on the first Community Mission Clean-Up Project.

Council Member Moore asked for an update of the status of the health of Shane Casteel. Human Resources Director, Doug Edwards reported to the Council as he had visited him at the hospital last evening. When asked if we could do anything for them, they asked that we pray.

City Attorney Betz presented 2 resolutions for consideration by the City Council.

A RESOLUTION FOR THE BOARD OF MAYOR AND COUNCIL OF THE CITY OF LAWRENCEBURG, TENNESSEE TO WAIVE BUILDING PERMIT FEES ASSOCIATED WITH LAWRENCE COUNTY HABITAT BUILDS 2012B.

Motion to approve was made by Council Member Moore, with a second by Council Member Williams. Motion passed unanimously.

A RESOLUTION FOR THE CITY OF LAWRENCEBURG, TENNESSEE, TO ACCEPT THE BID OF WASTEQUIP IN THE AMOUNT OF NINETEEN THOUSAND THREE DOLLARS (\$19,003.00) FOR THE PURCHASE OF ONE (1) 20 CUBIC YARD OPEN TOP ROLL OFF CONTAINER, ONE (1) 30 CUBIC YARD OPEN TOP ROLL OFF CONTAINER AND THREE (3) 40 CUBIC YARD OPEN TOP ROLL OFF CONTAINERS FOR USE IN THE SANITATION DEPARTMENT.

Motion to approve was made by Council Member Fox, with a second by Council Member Williams. Motion passed unanimously.

With no further business to come before the Council a motion was made by Council Member Moore with a second by Council Member Fox to adjourn. Motion passed unanimously.
