

COUNCIL MEETING MINUTES
CITY OF LAWRENCEBURG

November 10, 2016

The Board of Mayor and Council met in regular session. The following members were present: Council Member Fox, Council Member Sevier, Council Member Williams, and Mayor Durham. Council Member Moore was absent.

With a quorum present the meeting was called to order by Mayor Durham. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the October 27, 2016 Council Meeting was made by Council Member Williams second by Council Member Fox. Motion passed unanimously.

Mayor Durham announced the closing of city offices on November 11 for Veterans Day and that the annual Veterans Day Parade starts at 11:00 a.m. on that date. He also added a thank you from Pat Ford, the Mayor of Pulaski to the Lawrenceburg Fire Department for their assistance in the fire.
