

COUNCIL MEETING MINUTES  
CITY OF LAWRENCEBURG

April 27, 2017

The Board of Mayor and Council met in regular session. The following members were present: Council Member Fox, Council Member Sevier, Council Member Williams and Mayor William K. Durham. Council Member Moore was absent.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the April 13, 2017 Council Meeting was made by Council Member Fox, with a second by Council Member Williams. Motion passed unanimously.

City Administrator Chris Shaffer updated the Council on accomplishments of several city employees. Seth Rhinehart and Mathew Langford are graduating from the Firefighters Academy as well as a Reserve Fireman Hunter Womble. Fire Chief Jay Moore has been appointed to the Fire Fighting Personnel Standards and Education Commission.

Public Works Director, Jerry Smith, was congratulated on the paving job on Fall River Road and Prosser Road.

The Lions Club and the Parks Department are working on a new welcome sign for the Disc Golf Course.

We have received notice to proceed with the design on Safe Routes to School Grant and received several request for qualifications for CEI work.
