### COUNCIL MEETING MINUTES CITY OF LAWRENCEBURG

### August 28, 2014

The Board of Mayor and Council met in regular session. The following members were present: Council Member Fox, Mayor Keith Durham, Council Member Williams, and Council Member Sevier. Council Member Moore was absent.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the August 14, 2014 Council Meeting was made by Council Member Sevier, with a second by Council Member Williams. Motion passed unanimously.

Mayor Durham presented a Retirement Award to Rodney Wilkerson for 26 years of service to the Board of Mayor and Council and the citizens of Lawrenceburg.

City Administrator, Chris Shaffer, informed the Council Biometrics Health Screening is today and Friday. Jennifer Poland with TML will be here for a meeting at 1 PM to go over the new workers comp law.

Sam Clift has been hired as the mechanic in the Public Work Department and with the retirement of Rodney Wilkerson that department will have an opening for a heavy equipment operator.

The weekly department managers meetings will begin taking on disaster management training for department heads at the end of each meeting.

The Babe Ruth field wall is almost complete and sod has been placed in areas that needed it.

Joe Baxter, EMA Director, informed the Council of the disaster training he will be conducting and informed them that at some point, they will need to be involved.

Mr. James Gray spoke to the Council concerning the parking on Gallaher Boulevard. Those that are not allowed to park on Carroll Avenue are now parking on Gallaher, causing the street to be too narrow for emergency vehicles to get through.

The Council will give the situation serious consideration and asked personnel to seek a solution.

Discussion began with the introduction of three speakers. Carol Dail, Gerald Spear and Mary Ann Golden all presented their feelings both positive and negative on the subject. Their feelings were considered and the ordinance was amended as below.

A motion was made by Council Member Williams to remove the sentence "Signage should not be displayed more than 1000 yards from the site of the sale." Motion received a second by Council Member Sevier, motion passed unanimously.

A motion was made by Mayor Durham to change the number of consecutive days a sale may run from 2 to 3. The motion received a second by Council Member Sevier, motion passed unanimously.

Motion to approve Ordinance 1139 as amended passed unanimously.
