July 10, 2014

The Board of Mayor and Council met in regular session. The following members were present: Council Member Fox, Mayor Keith Durham, Council Member Moore, Council Member Sevier and Council Member Williams.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the June 26, 2014 Council Meeting was made by Council Member Williams, with a second by Council Member Sevier. Motion passed unanimously.

Mayor Durham Presented Anthony Nugent a retirement plaque for over 22 years of service to the Lawrenceburg Police Department.

Mayor Durham also presented an award to Tina Sowell for achieving certification as a Playground Safety Inspector.

A RESOLUTION OF THE BOARD OF MAYOR AND COUNCIL OF THE CITY OF LAWRENCEBURG, TENNESSEE TO PARTICIPATE IN THE TML RISK MANAGEMENT POOL "SAFETY PARTNERS" LOSS CONTROL MATCHING GRANT PROGRAM

Motion to approve was made by Council Member Moore, with a second by Council Member Sevier. Motion passed unanimously.

A RESOLUTION AUTHORIZING THE CITY OF LAWRENCEBURG TO ENTER INTO A CONTRACT TO AUDIT ACCOUNTS WITH THE ACCOUNTING FIRM OF YEARY, HOWELL AND ASSOCIATES FOR THE PERIOD FROM JULY 1, 2013 TO JUNE 30, 2014.

Motion to approve was made by Council Member Williams, with a second by Council Member Moore. Motion passed unanimously.

A RESOLUTION FOR THE CITY OF LAWRENCEBURG, TENNESSEE TO INCREASE THE COST FOR SALE OF LOTS IN MIMOSA CEMETERY TO \$400.00 PER LOT AND THE FUNDS FROM THE SALE TO BE PLACED IN THE MIMOSA CEMETERY TRUST FUND.

Motion to approve was made by Council Member Fox, with a second by Council Member Williams.

Council Member Fox made a motion to amend the Resolution to have the Resolution to take effect in 60 days to give citizens an opportunity to purchase lots before the price goes up. Motion received a second by Council Member Williams. Motion passed.

Council Member Fox further amended the Resolution to limit the amount of lots a person could purchase in the next sixty days to two lots. Motion received a second by Council Member Williams. Motion passed.

Vote to pass as amended was unanimous.

Alan Betz informed the Council of the upcoming Babe Ruth Thirteen and Fourteen Year Old Tournaments and Council Member Moore spoke of the Cal Ripken 8 Year Old Tournament.

Darren Goolsby, Lawrenceburg Assistant Chief of Police, presented awards to four officers for action taken during the CVS Pharmacy hold up and hostage situation.

Letters of Recognition were presented to Sammy McConnell, Jason Lee and Jesse Mills for support and Blake Grooms received a letter of Commendation for working with the suspect and negotiating the release of the hostage.

Assistant Chief Goolsby also thanked County and State Officers and the Lawrenceburg Fire Department as well as off duty officers that came to assist. There were no injuries or fatalities during the ordeal.

With no further business to come before the Council a motion was made by Council Member Moore, with a second by Council Member Sevier.
