CITY OF LAWRENCEBURG

July 28, 2016

The Board of Mayor and Council met in regular session. The following members were present: Council Member Fox, Mayor Keith Durham, Council Member Sevier, and Council Member Williams. Council Member Moore was absent.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the July 11, 2016 Council Meeting was made by Council Member Sevier second by Council Member Fox. Motion passed unanimously.

City Administrator, Chris Shaffer, introduced Ms. Shirley Lemay. She asked the City Council if they wanted to be involved in digging up a time capsule next July at David Crockett Park.
