July 11, 2013

The Board of Mayor and Council met in regular session. The following members were present: Mayor Keith Durham, Council Member Moore, Council Member Williams, Council Member Sevier and Council Member Fox.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the June 27, 2013 Council Meeting was made by Council Member Williams, with a second by Council Member Sevier. Motion passed unanimously.

A RESOLUTION OF THE BOARD OF MAYOR AND COUNCIL OF THE CITY OF LAWRENCEBURG, TENNESSEE TO AMEND RESOLUTION 93-5-3D AND THE LAWRENCEBURG FIRE DEPARTMENT RULES AND REGULATIONS TO ADOPT A POLICY TO ALLOW PERSONS EMPLOYED BY THE CITY OF LAWRENCEBURG FIRE DEPARTMENT TO LIVE WITHIN TEN (10) ROAD MILES OF A GEOGRAPHICALLY CENTERED LOCATION (THE INTERSECTION OF HIGHWAY 64 AND HIGHWAY 43; COMMONLY KNOWN AS CYCLONE CORNER).

Motion to approve was made by Council Member Fox, with a second by Council Member Sevier. Motion passed unanimously.
