

COUNCIL MEETING MINUTES
CITY OF LAWRENCEBURG

May 11, 2017

The Board of Mayor and Council met in regular session. The following members were present: Council Member Fox, Council Member Sevier, and Mayor William K. Durham. Council Member Moore and Council Member Williams was absent.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the April 27, 2017 Council Meeting was made by Council Member Fox, with a second by Council Member Sevier. Motion passed unanimously.

Eddie Cullifer received a letter of commendation for his actions when an explosion happened in the back of the garbage truck he was driving. He moved the truck away from businesses and called 911. His actions saved the city thousands of dollars.

City Administrator, Chris Shaffer updated the Council on the progress of converting our section of the building to accommodate LUS. According to Architect Jerry Reynolds construction should start by the end of this month.
