

COUNCIL MEETING MINUTES  
CITY OF LAWRENCEBURG

May 8, 2014

The Board of Mayor and Council met in regular session. The following members were present: Council Member Fox, Mayor Keith Durham, Council Member Moore, Council Member Sevier and Council Member Williams.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the April 24, 2014 Council Meeting was made by Council Member Williams, with a second by Council Member Sevier. Motion passed unanimously.

Mayor Durham presented two Proclamations; the first was for May as National Elder Law Month, with Paul Plant to accept. The second was for May as Foster Care Month, with Michelle Ceylan to accept.

City Administrator, Chris Shaffer informed the Council of a Key Club function tonight and Mr. Joe Baxter gave an update on the Storm Water Management Projects as well as information on the future paving of Helton and Remke Drives.

Judy Hartsfield informed the Council about the second annual Health Fair for employees and retirees. She has twice the number of vendors this year. It will be held June 5<sup>th</sup> from 9 am until 12:00 noon.

The financials for March 2014 were accepted by the Council.

Motion to approve was made by Council Member Moore, with a second by Council Member Williams.

Assistant Chief Goolsby gave a report on the renovation of the old administration building for the Police Department.

Former Mayor, Blake Lay and former County Mayor, Steve Hill were present at the meeting representing the Chamber of Commerce. Members of the Chamber have begun attending city and county meetings in order to better inform the local elected officials on projects the Chamber is working on. One new area for the Chamber is focusing on retail and helping them grow their base and customers.

Council Member Sevier complemented Mr. Lay and Mr. Hill for volunteering their time for the benefit of Lawrenceburg and Lawrence County.
