

COUNCIL MEETING MINUTES  
CITY OF LAWRENCEBURG

June 22, 2017

The Board of Mayor and Council met in regular session. The following members were present: Council Member Fox, Council Member Sevier, Mayor William K. Durham, Council Member Moore and Council Member Williams.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the June 8, 2017 Council Meeting was made by Council Member Williams, with a second by Council Member Sevier. Motion passed unanimously.

Terry Gray received a Retirement Award for over 40 years of service to the City of Lawrenceburg Administration Department.

Mayor Durham announced the closing of city offices on Tuesday, July 4<sup>th</sup>. An invitation for the June 26, induction of Rachel Bridges as David Crockett Park Manager at 1:30 p.m. and an open house at STHC Hospital from 8:30 until 10:00 a.m. The Annual Fireworks Display will be at LCHS around dark thirty on July 4.

The City Administrator, Chris Shaffer announced that the city will be trimming trees on many streets in Lawrenceburg due to limbs being too low for emergency apparatuses especially the fire trucks to go under; causing damage to the equipment. The City of Lawrenceburg has joined the Tennessee Healthier Work Force Program.
