

COUNCIL MEETING MINUTES  
CITY OF LAWRENCEBURG

October 11, 2012

The Board of Mayor and Council met in regular session. The following members were present: Council Member Robin Williams, Council Member Ronald Fox, Mayor Keith Durham, Council Member Moore, and Council Member Sevier.

With a quorum present the Mayor called the meeting to order. The meeting opened with Prayer and the Pledge of Allegiance.

The City has three employees that lost their children to automobile accidents last evening. Chad Moore led the prayer remembering the families of Jim Bentley, Jim Abbott and Todd Pesnell.

Motion to approve the minutes of the September 28, 2012 Council Meeting was made by Council Member Williams with a second by Council Member Sevier. Motion passed unanimously.

Under Department Managers report Benefits Administrator, Doug Edwards informed the Council of an option for our retirees covered by our EHO Drug Plan to get medication through International Sources.

The Mayor asked for the Council's opinion and all voted yes with Council Member Sevier voting no. The ayes carried.

City Attorney Betz presented 1 ordinance and 1 resolution for consideration by the City Council.

ORDINANCE NO. 1103

AN ORDINANCE TO AMEND ORDINANCE NO. 789, ENTITLED THE "ZONING ORDINANCE" OF THE CITY OF LAWRENCEBURG, THE LAWRENCEBURG MUNICIPAL CODE, TITLE 14, CHAPTER 2, 14-201 LAND USE TO BE GOVERNED BY ZONING ORDINANCE PUBLISHED AS APPENDIX 1, VOLUME II OF THE LAWRENCEBURG MUNICIPAL CODE, ARTICLE VII, ADMINISTRATION AND ENFORCEMENT, SECTION 7.070 VARIANCES, C. FEE. – Second and Final Reading

Motion to approve on second and final reading was made by Council Member Sevier, with a second by Council Member Fox. Motion passed unanimously.

RESOLUTION(S)

A RESOLUTION OF THE BOARD OF MAYOR AND COUNCIL THE CITY OF LAWRENCEBURG TO APPLY FOR AN APPALACHIAN REGIONAL COMMISSION (ARC) GRANT IN THE AMOUNT OF FIVE HUNDRED THOUSAND DOLLARS (\$500,000.00) FOR USE IN THE TEAM LAWRENCE COMMERCE PARK

Motion to approve was made by Council Member Moore, with a second by council Member Fox. Motion passed unanimously.

City Attorney Betz presented an agreement between the City of Lawrenceburg and the United States Department of the Interior, National Park Service, National Trails, Intermountain Region for installation of Official National Historic Trail Signs for the Bell's route of the Trail of Tears National Historic Trail. The last paragraph is especially noted as: The City of Lawrenceburg Tennessee hereby agrees to indemnify, save, and hold harmless the United States against all fines, claims, damages, losses, judgements, and expenses arising out of, or from, any omission or activity of such person organization, its representatives, or employees.

Motion to approve the agreement was made by Council Member Moore, with a second by Council Member Williams. Motion passed unanimously.

With no further business to come before the Council a motion was made by Council Member Moore with a second by Council Member Williams to adjourn. Motion passed unanimously.
