

COUNCIL MEETING MINUTES  
CITY OF LAWRENCEBURG

April 26, 2012

The Board of Mayor and Council met in regular session. The following members were present: Mayor Durham, Council Member Robin Williams, Council Member Chad Moore, Council Member Jamie Sevier and Council Member Ronald Fox.

With a quorum present Mayor Durham called the meeting to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the April 12, 2012 Council Meeting was made by Council Member Williams with a second by Council Member Fox. Motion passed unanimously.

Mayor Durham announced the appointment of Geeta Shah, to complete the term of her late husband Uday Shah, on the Lawrenceburg Housing Authority Board with the term to expire December 9, 2014.

Mayor Durham presented a Certificate of Appreciation plaque to Roy and Linda Ledbetter for their service to the citizens of Lawrenceburg through the Ledbetter Drug Store located at 47 Public Square. Ledbetter's Drug Company has closed after over 50 years of serving ice cream, medical prescriptions and the center for political discussions local and national.

Mr. Ledbetter expressed his appreciation of the plaque.

Mayor Durham and Photographer, Jimmy Moore unveiled an original photo of the destruction of the Twin Towers in aftermath of the attack on America on 9-11-2001.

Mayor Durham asked that the photo remain hanging in the Administration Building as a reminder of the event and in recognition of Mr. Moore's work.

Mr. Moore stated, "Any artist would tell you it is an honor to be recognized by your hometown, and I am truly appreciative".

William McLain informed the Council that he asked Randy Jones to be in the meeting. Each Council Member received a drawing, by our engineer, of Centennial Boulevard as a one-way street.

After some discussion Mayor Durham requested the proposal go back to the Planning Commission for their recommendation to the Council.

The next item on the agenda is Old Business with a note about need for discussion on the number of liquor stores inside the City of Lawrenceburg. The Council decided to have a work session on the matter; it will be discussed at the next budget work session scheduled for Tuesday May 1, at 12:00 noon.

City Attorney Betz presented 1 ordinance and 1 resolution for consideration by the City Council.

AN ORDINANCE TO AMEND ORDINANCE NO.1081 ENTITLED BUDGET APPROPRIATIONS OF REVENUE AND EXPENDITURES FOR THE 2011-2012 FISCAL YEAR FOR THE CITY OF LAWRENCEBURG, TENNESSEE FOR JOINT ECONOMIC AND COMMUNITY DEVELOPMENT BOARD AND THE SAFETY BUDGET. Second and final reading.

Motion to approve on second and final reading was made by Council Member Moore, with a second by Council Member Sevier. Motion passed unanimously.

A RESOLUTION FOR THE CITY OF LAWRENCEBURG, TENNESSEE, TO ACCEPT THE PROPOSAL OF SUNTRUST BANK TO FINANCE THE PURCHASE OF TWO (2) SANTIATION TRUCKS IN THE AMOUNT OF \$400,000.00 AT A RATE OF 1.86% .

Motion to approve was made by Council Member Williams, with a second by Council Member Fox. Motion passed unanimously.

Council Member Sevier informed the Council that the first week of May in the 125 Anniversary of Sacred Heart Church in Lawrenceburg.

With no further business to come before the Council a motion was made by Council Member Moore with a second by Council Member Williams to adjourn. Motion passed unanimously.
