

COUNCIL MEETING MINUTES  
CITY OF LAWRENCEBURG

March 13, 2014

The Board of Mayor and Council met in regular session. The following members were present: Council Member Williams, Council Member Fox, Mayor Keith Durham, Council Member Sevier. Council Member Moore was absent.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the February 27, 2014 Council Meeting was made by Council Member Williams, with a second by Council Member Fox. Motion passed unanimously.

City Administrator, Chris Shaffer informed the Council that the Fire Truck decision has been postponed but the decision must be made by next Tuesday. Also, we have 30 computers running on Windows XP and the updates on that are expiring and we need to make a decision concerning that. Mr. Darrell Valentine was introduced with a new proposal for the City.

Mr. Darrell Valentine would like to purchase the present "Old Timers Club" Building and three parking lots that belong to city. He would lease another building; he plans to purchase; to the city for a period of two years for \$1.00 per year for the "Club" to use.

After discussion it was decided to hold a work session on Tuesday, March 18, at 3:00 PM.
