

COUNCIL MEETING MINUTES  
CITY OF LAWRENCEBURG

October 10, 2013

The Board of Mayor and Council met in regular session. The following members were present: Council Member Williams, Council Member Sevier, Council Member Fox, and Mayor Keith Durham. Council Member Moore was absent.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the September 26, 2013 Council Meeting was made by Council Member Williams, with a second by Council Member Sevier. Motion passed unanimously.

Mayor Durham announced the closing of City Offices on October 14 in observance of Columbus Day.

City Administrator Chris Shaffer informed the Council we have hired two new employees in the Sanitation Department and he is working on an contract with Rotary Club on the bleacher construction.

Mayor Durham asked for a sketch/elevation drawing to show the citizens what they will look like.

LUS Financials for September were accepted by the Council.

City Attorney Betz presented one ordinance and three resolutions for consideration.

Motion to approve on second and final reading was made by Council Member Williams, with a second by Council Member Fox. Motion passed unanimously.
