April 14, 2016

AN ORDINANCE TO AMEND ORDINANCE NO. 789, ENTITLED THE "ZONING ORDINANCE" OF THE CITY OF LAWRENCEBURG, THE LAWRENCEBURG MUNICIPAL CODE, TITLE 14, CHAPTER 2, 14-201 LAND USE TO BE GOVERNED BY ZONING ORDINANCE PUBLISHED AS APPENDIX 1, VOLUME II OF THE LAWRENCEBURG MUNICIPAL CODE; ARTICLE VII, ADMINISTRATION AND ENFORCEMENT SECTION 7.070 (C) FEES [ORDINANCE 778]; ARTICLE VII, SECTION 7.030 (C) FEES [ORDINANCE 913]; ARTICLE VII SECTION 7.070 VARIANCE, (C) FEES [ORDINANCE 1103]; AND TO ESTABLISH A SCHEDULE OF FEES FOR PLANNING, ZONING AND PERMITTING – First Reading
