June 9, 2016

The Board of Mayor and Council met in regular session. The following members were present: Council Member Fox, Mayor Keith Durham, Council Member, Council Member Moore, Council Member Sevier and Council Member Williams.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve on first reading was made by Council Member Sevier with a second by Council Member Moore.

Motion to approve was made by Council Member Williams, with a second by Council Member Fox. Motion passed unanimously.

A RESOLUTION FOR THE CITY OF LAWRENCEBURG, TENNESSEE TO PURCHASE A USED VEHICLE FROM CHICAGO MOTORS OR ASIAN MOTORS FOR THE POLICE DEPARTMENT TO BE PAID THROUGH THE DRUG FUND

Motion to approve was made by Council Member Moore, with a second by Council Member Sevier. Motion passed unanimously.

A RESOLUTION FOR THE BOARD OF MAYOR AND COUNCIL OF THE CITY OF LAWRENCEBURG TO ACCEPT THE BID FROM ROGERS GROUP FOR THE 2016 SPRINGER ROAD IMPROVEMENTS IN THE AMOUNT OF TWO MILLION ONE HUNDRED THIRTY THREE THOUSAND EIGHT HUNDRED EIGHTY TWO DOLLARS (\$ 2,133,882.00)

Motion to approve was made by Council Member Williams, with a second by Council Member Fox. Motion passed unanimously.

A RESOLUTION FOR THE CITY OF LAWRENCEBURG TO JOIN WITH THE JOINT ECONOMIC DEVELOPMENT BOARD OF LAWRENCE COUNTY IN APPLYING FOR AND ACCEPTING A GRANT THROUGH THE STATE OF TENNESSEE DEPARTMENT OF ECONOMIC AND DEVELOPMENT IN THE AMOUNT OF \$326,300.00 TO UPGRADE EXISTING COUNTY FARM ROAD, WITH THE CITY TO PROVIDE THE 5% MATCH NOT TO EXCEED \$16,500.00
