

COUNCIL MEETING MINUTES  
CITY OF LAWRENCEBURG

May 12, 2016

The Board of Mayor and Council met in regular session. The following members were present: Council Member Fox, Mayor Keith Durham, Council Member, Council Member Moore, Council Member Sevier and Council Member Williams.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the April 28, 2016 Council Meeting was made by Council Member Williams second by Council Member Sevier. Motion passed unanimously.
