

COUNCIL MEETING MINUTES
CITY OF LAWRENCEBURG

January 23, 2014

The Board of Mayor and Council met in regular session. The following members were present: Council Member Williams, Council Member Fox, Mayor Keith Durham, Council Member Moore and Council Member Sevier.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the January 9, 2014 Council Meeting was made by Council Member Williams, with a second by Council Member Sevier. Motion passed unanimously.

City Administrator, Chris Shaffer informed the Council that Mr. Sparkman came to Lawrenceburg and inspected the Crockett Theater Marquee again and added some masonry and window repair as well as repairing the marquee.

Mr. Shaffer introduced Halie Gallik with the Tennessee Municipal League Pool. Ms. Gallik made a presentation to the Council thanking them for being a member of the Pool for 30 years.

City Attorney Betz presented one ordinance and two resolutions for consideration.

Motion to approve was made by Council Member Williams, with a second by Council Member Sevier. Motion passed unanimously.

City Attorney, Alan Betz, informed the Council that a 1 PM today in the City Auditorium, Mr. Robert Feherty will meet to sign the contract for the 15 Year Old Babe Ruth World Series to be held in Lawrenceburg in August of 2015.

He also stated that the City will receive a \$15,000.00 grant toward the lights at the Babe Ruth Field through Babe Ruth International.
