

COUNCIL MEETING MINUTES
CITY OF LAWRENCEBURG

June 9, 2011

The Board of Mayor and Council met in regular session. The following members were present: Council Member Ronald Fox, Council Member Jamie Sevier and Council Member Robin Williams. Mayor Durham and Council Member Jerry Moore were absent.

With a quorum present Vice Mayor Williams called the meeting to order. The meeting opened with Prayer and the Pledge of Allegiance.

Motion to approve the minutes of the May 26, 2011 Council Meeting was made by Council Member Sevier with a second by Council Member Fox. Motion passed unanimously.

Vice Mayor Williams congratulated the Fire Department on the very successful benefit they had for fellow Firefighter Kenny Rhinehart.

City Administrator McLain informed the Council about a complaint concerning the swimming pool hours. Discussion on the matter will be held when Park Director, Beth Campbell returns from vacation.

Lawrenceburg Utility Systems Contract Accountant John Cain presented LUS Financials for discussion with the Lawrenceburg City Council. He explained the documents and answered questions concerning the Electric, Gas, Water and Sewer Departments.

City Administrator William McLain presented the City of Lawrenceburg Financials for discussion with the Council.

ORDINANCE 1075 AN ORDINANCE OF THE CITY OF LAWRENCEBURG, TENNESSEE ADOPTING A PRIVILEGE TAX ON RETAIL SALE OF ALCOHOLIC BEVERAGES FOR CONSUMPTION ON THE PREMISE AND TO ESTABLISH TITLE 8 CHAPTER 3 OF THE LAWRENCEBURG MUNICIPAL CODE.

City Attorney Betz asked the Council to amend Ordinance 1075 before proceeding with second and final reading. He asked that the paragraph stating (Further, for the exercise of such privilege, the following taxes are hereby levied to be earmarked for and allocated to the commission for the purpose of administration and enforcement of the duties, powers and function of the commission, and are to be paid in accordance with the following schedule) be deleted. This referenced the ABC privilege taxes rather than the city.

Motion to amend Ordinance 1075 was made by Member Sevier with a second by Council Member Williams. Motion passed.

Motion to approve Ordinance 1075 as amended was made by Council Member Fox, with a second by Council Member Williams. Motion passed unanimously.

ORDINANCE 1076 AN ORDINANCE TO AMEND ORDINANCE NO.1065 ENTITLED BUDGET APPROPRIATIONS OF REVENUE AND EXPENDITURES FOR THE 2010-2011 FISCAL YEAR FOR THE CITY OF LAWRENCEBURG, TENNESSEE. First Reading.

Motion to approve Ordinance 1076 on first reading was made by Council Member Fox, with a second by Council Member Sevier. Motion passed unanimously.

ORDINANCE NUMBER 1077 AN ORDINANCE TO AMEND TITLE 8 SECTION 1 OF THE LAWRENCEBURG MUNICIPAL CODE ENTITLED ALCOHOLIC BEVERAGES. First Reading.

Motion to approve on first reading was made by Council Member Fox, with a second by Council Member Sevier. Motion passed unanimously.

With no further business to come before the Council a motion was made by Council Member Sevier, with a second by Council Member Williams to adjourn. Motion passed unanimously.
