

COUNCIL MEETING MINUTES  
CITY OF LAWRENCEBURG  
March 25, 2010

The Board of Mayor and Council met in regular session. The following members were present: Council Member Jamie Sevier, Council Member Jerry Moore, Mayor Durham, Council Member Robin Williams and Council Member Ronald Fox.

With a quorum present Mayor Durham called the meeting to order. The meeting opened with Prayer and the Pledge of Allegiance.

A motion to approve the minutes of the March 11, 2010 meeting was made by Council Member Williams, with a second by Council Member Sevier. Motion passed unanimously.

Mayor Durham announced the closing of city offices on Friday, April 2<sup>nd</sup> in observance of Good Friday and informed the Council that Senator Bob Corker would be at Columbia State Community College at 8:30 a.m. on April 29<sup>th</sup> if they would like to meet with him.

City Administrator William McLain asked the Council to set a date to begin working on the budget. It was decided a work session would be held after the next Council Meeting, April 8<sup>th</sup>.

City Attorney Betz had 3 ordinance and 4 resolutions for Council consideration:

ORDINANCE NO. 1060

AN ORDINANCE TO AMEND ORDINANCE NUMBER 789 ENTITLED THE "ZONING ORDINANCE OF THE CITY OF LAWRENCEBURG, TENNESSEE" AND TO AMEND THE LAWRENCEBURG MUNICIPAL CODE; TITLE 14; CHAPTER 2: SECTION 14-201. LAND USE TO BE GOVERNED BY ZONING ORDINANCE.

A motion was made by Council Member Moore to table Ordinance 1060, with a second by Council Member Sevier. Motion passed unanimously. Ordinance Number 1060 is tabled.

ORDINANCE NUMBER 1061

AN ORDINANCE TO ANNEX CERTAIN PROPERTY LOCATED ON WEST POINT ROAD AND FRANKLIN DRIVE CONSISTING OF APPROXIMATELY 10.005 ACRES AS REQUESTED BY JOHN TROUP.

Motion to approve on first reading was made by Council Member Williams, with a second by Council Member Moore. Motion passed unanimously.

AN ORDINANCE TO AMEND ORDINANCE NO.1055 ENTITLED BUDGET APPROPRIATIONS OF REVENUE AND EXPENDITURES FOR THE 2009-2010 FISCAL YEAR FOR THE CITY OF LAWRENCEBURG, TENNESSEE.

Motion to pass on first reading was made by Mayor Durham, with a second by Council Member Sevier. Motion passed unanimously.

2010-25-3D A RESOLUTION FOR THE BOARD OF MAYOR AND COUNCIL OF THE CITY OF LAWRENCEBURG, TENNESSEE TO REAPPOINT TRACY GOBBLE, KENNY BEAVERS AND T. J. HUGHES TO THE INDUSTRIAL DEVELOPMENT BOARD

Motion to approve was made by Council Member Williams, with a second by Council Member Fox. Motion passed unanimously.

Mayor Durham gave each Council Member a portion of the Zoning Ordinance dealing with the Historical Zoning Board and asked them to study that portion as he would like to appoint a board to help preserve some of our historical sites.

With no further business to come before the Council, a motion to adjourn was made by Council Member Sevier, with a second by Council Member Williams Motion passed unanimously.
