July 28, 2022

The Board of Mayor and Council met in regular session.

The following members were present: Council Member Sevier, and Council Member Williams. Council Member Moore and Mayor Lay Council Member Fox was absent.

With a quorum present the meeting was called to order. The meeting opened with Prayer and the Pledge of Allegiance.
